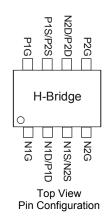

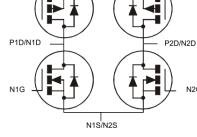

Internal Schematic

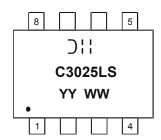

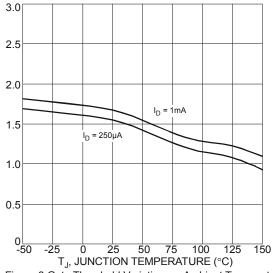
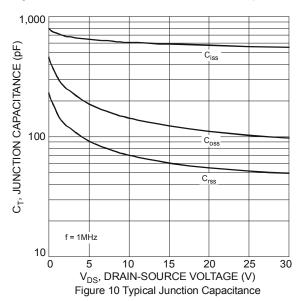
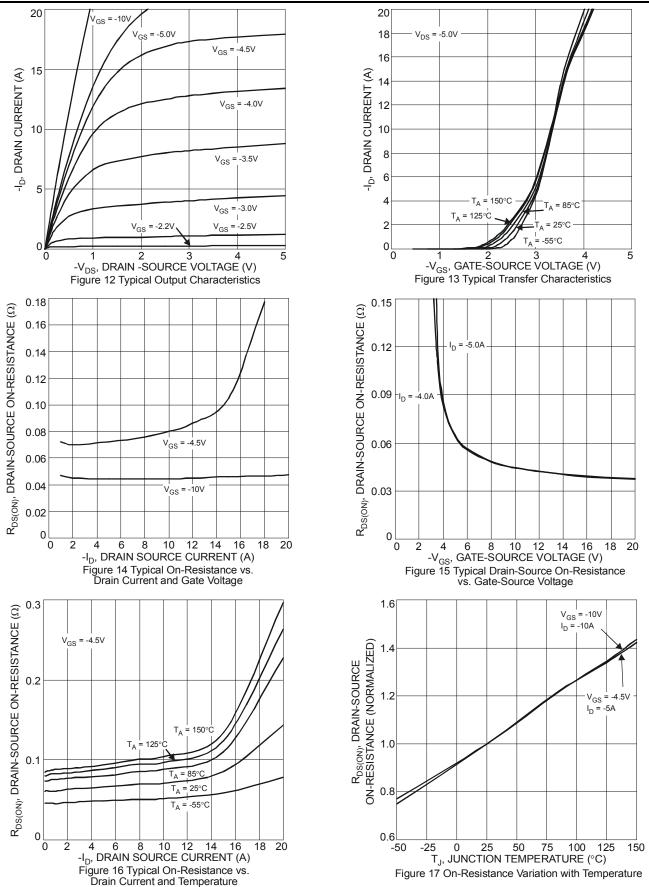


Figure 8 Gate Threshold Variation vs. Ambient Temperature

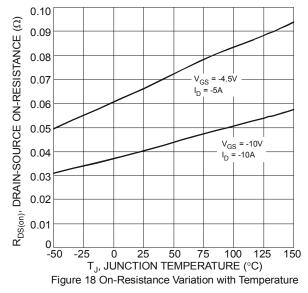


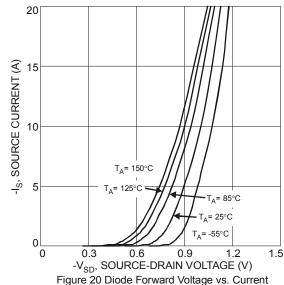


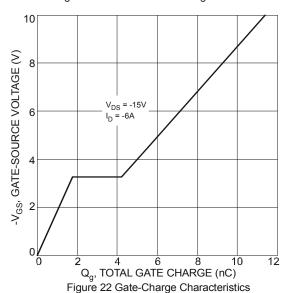

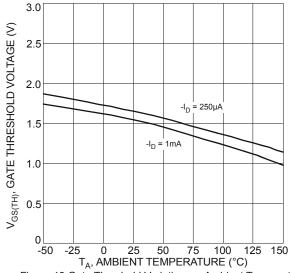
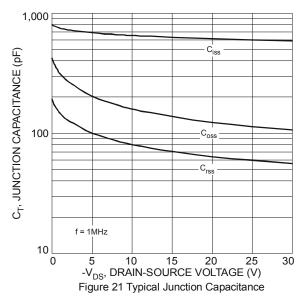


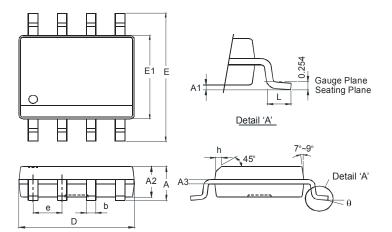
Figure 19 Gate Threshold Variation vs. Ambient Temperature

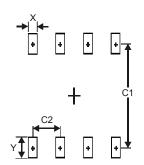
